The Prevent Duty

At Deanshanger Primary School we want our children to be 'good' citizens well prepared for the diverse world beyond our school. We are committed to designing our curriculum to allow this rather than it happening incidentally. It is easy to imagine that members of our community do not engage with radical activities, but this would not only be naïve, but very dangerous. Our curriculum should prepare our children for life in the modern Britain and promote community cohesion in all forms.

What is the Prevent Duty?

Prevent is a government strategy designed to stop people becoming terrorists or supporting terrorist or extremist causes. The Prevent strategy covers all types of terrorism and extremism, including the extreme right wing, violent Islamist groups and other causes.

The school's designated safeguarding leads are responsible for the Prevent Duty.

How does the Prevent Duty apply to schools?

From July 2015 all schools (as well as other organisations) have a duty to safeguard children from radicalisation and extremism. This means we have a responsibility to protect children from extremist and violent views the same way we protect them from bullying and antisocial behaviours. Importantly, we provide a safe place for pupils to discuss these issues so they better understand how to protect themselves. Our Prevent Duty is in line with our safeguarding duties and British Values.

What does this mean in practice?

Many of the things we already do in school to help children become positive, happy members of society also contribute to the Prevent duty. These include:

- Exploring other cultures and religions in class sessions, assemblies, special events and promoting diversity;
- Always challenging prejudices and racist comments and tackling (and reporting) them if overheard;
- Developing critical thinking skills and a strong, positive self-identity through all subject areas;
- Promoting the spiritual, moral, social and cultural development of pupils, as well as British values such as democracy and the rule of law in our revised PSHE curriculum (March 2016);
- By using filters on the internet to make sure they cannot access extremist and terrorist materials and ensuring children never use the computers without supervision – this is part of our E-Safety duty;
- By ensuring that all visitors who come into the school to work with pupils alone have a DBS check;
- By keeping our staff up to date with safeguarding information and training - all staff have had recent Safeguarding and Prevent training;
- Ensuring that all members of the community are aware who to contact if they have any concerns about our Prevent Duty or any other aspect of safeguarding.
- Keeping strong links with our Protective Services Officer (PSO) for support as required and to lead school assemblies.

The school annually reviews the Prevent Duty Risk Assessment (Appendix 1) in order to ensure that all aspects of Prevent Duty and safeguarding are considered.

Key terms

- **Extremism** – vocal or active opposition to fundamental British values such as democracy, the rule of law and tolerance of different faiths and beliefs
- **Ideology** – a set of beliefs
- **Terrorism** – a violent action against people or property, designed to create fear and advance a political, religious or ideological cause
- **Radicalisation** – the process by which a person comes to support extremism and terrorism.

Frequently asked questions

How does Prevent relate to British values?

Schools have been required to promote British values since 2014, and this will continue to be part of our response to the Prevent strategy. Our British Values Policy is held on the school website under curriculum www.deanshangerprimary.co.uk .

Isn't my child too young to learn about extremism?

The Prevent strategy is not just about discussing extremism itself, which may not be appropriate for younger children. It is also about teaching children values such as tolerance and mutual respect. The school will make sure any discussions are suitable for the age and maturity of the children involved.

Is extremism really a risk in our area?

Extremism can take many forms and occurs in all areas of the country. We aim to give children the skills to protect them from any extremist views they may encounter, now or later in their lives.
